### HAWAI'I SCHOOL HEALTH SURVEY

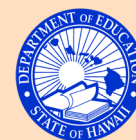
The Hawai'i School Health Survey is a joint project of the Hawai'i Departments of Education (DOE) and Health (DOH) and the University of Hawai'i's Curriculum Research & Development Group. It is largely funded by the DOH Substance Abuse Block Grant. The results are representative of the 25,667 regular public middle school students across the state of Hawai'i and the 3,764 Maui County public middle school students.

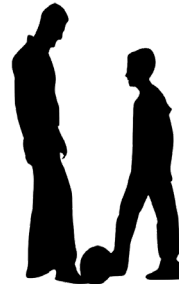

The YRBS was administered in the Spring semester in 2019 and, due to COVID-19, in the Fall semester in 2021. Students' home and school life was dramatically affected during the COVID-19 pandemic, which combined with change in administration dates may account for many of the findings.
